

Hi Peter, I know we run into the same problems with excessive heat in the office and room 11 every heating season. I have to run both boilers to get condensate back and it creates a lot of heat in those to rooms overnight. I can't leave windows open overnight to either of the rooms because kids can climb in. So my only alternative is to shut the boilers off and get complaints about being cold, and then I have to babysit the boilers at start up, adding a ton of water each time I shut them off and then chemical again. I'm putting in service requests to have fresh air fans installed, that I can leave on overnight, so these rooms aren't in the mid 80's each morning. There should be no problems with freezing pipes if they are mounted far enough away from heating pipes. Thanks Terry@Connaught

Thank you for your inquiry. In response to the particulars of your situation, I have asked one of our senior administrators to be in touch with you as there may be nuances I am unaware of.

In general, boundaries are established to try and distribute population appropriately for the capacity of the neighborhood school. They are reviewed and sometimes adjusted because school populations ebb and flow as a result of decisions made by parents over which the Board has no control: we don't get to decide where people buy or build.

Transportation service is provided to students who live far enough from a school to need the service: we establish walk limits to apply consistency because we are not funded to transport everyone.

I trust you will get a more detailed response once Mr. Luc Lerminaux, Superintendent RPS is in touch with you. Please do not hesitate to be back in touch if you have remaining questions.

Subject: Question for School Board Forum

Hi Katherine,

I am unable to attend the school board forum on December 3rd. I would like to ask the School Board a question and was directed to you in order to voice my concern. Thank you for helping me to raise my question with the Board.

I would like the Board to describe the rationale for Regina's public school boundaries, including boundaries for busing. My observation is that s chools in Regina are bounded by geographic landmarks that appear arbitrary and unrelated to population data or density (or geometry).

I understand that boundaries are necessary to encourage students to enrol in their nearest school. I notice, however, that students are not bused to their nearest school. Instead, they are bused to the nearest school in their zone. In our case, we live a 5 minute drive from our nearest school

(Ecole Connaught) but we are zoned to a school that is 45 minutes away on a school bus (Massey), and is not in my neighbourhood.

Here is my question:

If families are being encouraged to enrol children in their closest school (according to the School Board website), why is there no assurance of transportation to the nearest school?

The people who manage bus services should have the discretion to enable students to attend their nearest school. I find g overnment's recent commitment to put students first very promising. I am hopeful that our growing population and discussions about our school facilities will result in a renewed, deliberate focus on the interests of children.
