




Space Utilization




Population (ages 13-16)






Where existing students live



Where existing students live (segmented east)



TRANSPORTATION OF STUDENTS

Background

To ensure access to educational programs the Division may authorize the provision of the transportation for students.

Procedures

Regular Programs

1. Eligibility for Regular Program transportation is determined as follows:

Students must reside within the transportation services area for the designated school.

 Students must be enrolled in the Regular Program (i.e., not in a French Immersion Program or a Special Services Program or a Prekindergarten Program) and attending at their designated school,

 Kindergarten students who reside 0.6 km or farther from the designated elementary school are eligible for transportation services,

d. Grade 1 students who reside 0.6 km or farther from the designated elementary school are eligible for transportation services,

 e. Grades 2 to 8 students who reside 1.2 km or farther from the designated elementary school are eligible for transportation services,

f. In cases where a student who is eligible for transportation is to be picked up at home and returned to a caregiver or daycare, or vice versa, transportation in both directions shall only be provided if both addresses are in the attendance area of the designated school,

 Regular transportation services are not provided to high school students.

2. Regular Program route information includes:

 Routes may be up to 60 minutes one-way. This may be exceeded as a result of traffic congestion or road conditions. Our goal is to provide full neighbourhood coverage while minimizing ride times,

b. Students will be required to wait for school buses at collector stops. These stops will be determined by:

i-1. Stops will be provided near Kindergarten and/or Grade 1 student pick-up and drop-off locations,

ii.2. Other collector stops will be provided at locations which may require students to walk out of their local areas.

iii.3. d. Timing and scheduling of school bus routes is such that the arrival of a school bus for pick-up or drop-off should be within 5 to 10 minutes of

the scheduled time,

e. Bus stop locations are set for qualifying students only. Bus stops will
not be added for non-qualifying/exception students. Once bus stop
location are finalized, these locations are fixed and change requests
may not be accommodated,

f. Change requests may be considered, not guaranteed, and may be implemented on a timely basis depending on the impact on the overall transportation system. Change requests will require 3 to 5 days for

implementation.

Kindergarten Programs

1. Kindergarten program other transportation information includes:

a. When possible kindergarten students are picked up at a home or

caregiver location,

b. If the child is dropped off at home, the school bus operator will watch to ensure the child enters the home. If the door to the home is at the back of the house, the parent is required to wave to the school bus operator that the child is safe.

French Immersion Programs

4.2. Eligibility for French Immersion Program transportation is determined as follows:

 Students must reside within the transportation services area for the designated school,

b. Students must be enrolled in the French Immersion Program and attending at their designated school,

 Kindergarten students who reside 0.6 km or farther from the designated elementary school are eligible for transportation services,

d. Grade 1 students who reside 0.6 km or farther from the designated elementary school are eligible for transportation services,

e. Grade 2 to 8 students who reside 1.2 km or farther from the designated elementary school are eligible for transportation services,

f. In cases where a student who is eligible for transportation is to be picked up at home and returned to a caregiver or daycare, or vice

 Kindergarten students who reside 0.6 km or farther from the designated elementary school are eligible for transportation services,

 d. Grade 1 students who reside 0.6 km or farther from the designated elementary school are eligible for transportation services,

 e. Grade 2 to 8 students who reside 1.2 km or farther from the designated elementary school are eligible for transportation services,

 Students requiring wheelchairs will be provided transportation services, or

 g. Transportation services may be provided to qualifying high school students.

2. Special Services Program route information includes:

 Routes may be up to 60 minutes one-way. This may be exceeded as a result of traffic congestion or road conditions. Our goal is to provide full neighbourhood coverage while minimizing ride times,

 Students may be provided door-to-door curb side pick-up and drop-off transportation,

 School buses will not enter bays, places, cul-de-sacs, dead-end streets, or streets under construction. This procedure may exclude wheelchair school buses

3. Special Services Program general transportation information includes:

a. Routes are designed for specific students or situations and for stable, efficient routes with adequate neighbourhood coverage. As a neighbourhood roadway system evolves, changes to stop location, direction of travel and number of stops may be adjusted,

 Students picked-up or dropped off in a wheelchair school bus will usually have curb side pick-up and drop off,

 Timing and scheduling of school bus routes is such that the arrival of a school bus for pick-up or drop-off should be within 10 to 20 minutes of the scheduled time,

d. Bus stop locations are set for qualifying students only. Bus stops will not be added for non-qualifying/exception students. Once stop location are finalized, these locations are fixed and change requests may not be accommodated,

e. Change requests may be considered, not guaranteed, and may be implemented on a timely basis depending on the impact on the overall transportation system. Change requests will require 3 to 5 days for implementation.

f.Note for staff: EAL students that are provided an exception for transportation will only be awarded service from the date they enroll in school to the end of the current school year. Other Provisions

1. At the discretion of the Director or designate, transportation may also be

a. Students where an extreme health problem exists, as certified by the provision of a medical certificate;

b. Elementary school students required to attend schools where a major arterial road or other significant barrier presents a hazard to the students, or where the normal access road to the school is sufficiently open to weather conditions to present a hazard to students in severe winter weather; and

c. Students warranting special consideration.

d. Note to staff: MLUR - channel and tracks; ARCO - road(Arcola); MNEI - tracks; CORO - road(Avonhurst; CENT - tracks for French Immersion students)

2. Parents/guardians exercising the option of sending their children to schools other than those normally serving the areas in which they reside, in accordance with procedures 3, 4, or 5 of Administrative Procedure 310 -School Attendance Areas, shall be wholly responsible for any transportation arrangements and costs.

3. The provision of transportation may be limited to specific dates in instances where the distance and the weather, or other conditions, are contributing factors to the decision to convey students to school.

4. The Director or designate, may cancel transportation assistance for any students exhibiting inappropriate behaviour or for any other serious problem affecting the efficient operation of the transportation.

5. The Director or designate, may authorize alternative arrangements at any time specific conditions make changes advisable.

6. The Director or designate, may authorize payments to the parent/guardian of a student in lieu of transportation.

a. Exceptions will be permitted on Regular Program school buses but not on Regular Program light vehicle transportation (such as cabs),

b. Exceptions will be permitted for students attending their designated school only if,

Exceptions will not be granted for grade 6, 7 and 8 students.

2. Where a bus route services two schools in adjoining attendance areas (this does not effect French Immersion or Special Needs transportation), and where a student attended one of the schools at the beginning of the school year and subsequently moves (after at least two months) to a new address or to a new caregiver address in the attendance area of the other school referred to above, an exception for transportation services may be granted to that student to be transported to the school they began the school year at, subject to:

a. There is room on the existing bus (this does not apply to transportation

The student qualifies for regular transportation based on distance from school;

The bus does not have to alter its route; and

This exception will only be in effect, for this student, until the end of the current school year and will not be extended to this student for future years.

Exceptions will not be permitted for other Regular Program students.

Exceptions - French Immersion Programs

1. Exceptions may be provided for the following:

a. Exceptions will be permitted on French Immersion school buses but not on French Immersion light vehicle transportation (such as cabs),

b. Exceptions will be permitted for siblings of students attending a French Immersion Program that wish to attend the Regular Program at the French Immersion school,

Exceptions will only be permitted if the sibling walks to an existing stop and there is room available on the school bus,

Once the French Immersion student progresses from elementary school, the sibling will no longer be eligible for transportation to the French Immersion school.

 - Transportation Services must be requested prior to June 30, ii.
 - b. Students, and their siblings, will continue to receive transportation services as long as they continue to reside in the former Herchmer attendance area.
 - c. Exceptions will not be permitted for other Regular Program students that resided in former Herchmer attendance area after June 30, 2008, that wish to attend these schools.
- 2. Exceptions may be provided for the adjusted Judge Bryant School attendance+ area change as follows:
 - a. Eligibility criteria for the exception are:
 - Students, and their siblings, that attended and resided in the former Stewart Russell School attendance area as of June 30, 2008 will receive transportation services to Judge Bryant School or Dr. George Ferguson School
 - Transportation Services must be requested prior to June 30, ii. 2009.
 - b. Students, and their siblings, will continue to receive transportation services as long as they continue to reside in the former Stewart Russell attendance area,
 - c. Exceptions will not be permitted for other Regular Program students that resided in former Stewart Russell attendance area after June 30, 2008, that wish to attend these school.

Transportation Services shall be requested prior to June 30,

2009,

b. Students, and their siblings, will continue to receive transportation services as long as they continue to reside in this area,

c. Exceptions will not be permitted for other Regular Program students that resided in the former Wifrid Walker attendance area after June 30, 2008, that wish to attend W.F. Ready School.

Exceptions may be provided for the adjusted Elsie Mironuck School attendance area change as follows:

a. Eligibility criteria for the exception are:

Students, and their siblings, that attended and resided in the former Ken Jenkins School attendance area as of June 30, 2010 will be eligible to receive transportation services to Elsie Mironuck School or Ruth M Buck School, subject to the Regular Proams procedures above;

Transportation Services must be requested prior to June 30,

2010.

b. Students, and their siblings, will continue to receive transportation services as long as they continue to reside in the former Ken Jenkins School attendance area,

Exceptions will not be permitted for other Regular Program students that resided in former Ken Jenkins School attendance area after June 30, 2010, that wish to attend Ruth M Buck School.

5. Exceptions may be provided for the adjusted Centennial School French Immersion attendance area change as follows:
