



For those of you who were not in the staffroom at lunch today, I shared a little data I uncovered. Here goes:

Of the 27 grade eights at Connaught this year

- 6 have spent their entire elementary experience at Connaught
- Of those 6, 5 began in French Immersion
- Of those 5, 2 continued to complete in FI
- Of the 6, only one has completed the English program at Connaught

For one of our grade eight students Connaught is the 17th school from k-8.

Don't know what this all means but it is worth thinking about.
